501 Altavista Avenue- D. Roccasecca motion to APPROVE the planting of 2 trees at 501 Altavista - Shade Tree Commission will provide one tree (1); owner will be responsible to purchase one tree of her choice which are listed on the approved tree list. Consideration will be given to where the owner would like the trees planted. Final planting will be at the discretion of the Shade Tree Commission and PA 1 Call. R. Davis seconded the motion. NEW BUSINESS DISCUSSION:
